- Consortium of stakeholders led by EIPO established in 2004 to capture intangible value of selected fine coffees through strong branding;
- Trademark registration of Harrar, Sidamo & Yirgacheffe in 36 countries;
- Royalty-free licensing scheme and extensive cooperation network;
- Trademark opposition.

"Our coffee is grown on four million very small plots of land. Setting up a certification system would have been impracticable and too expensive. Trademarking was more appropriate to our needs. It was a more direct route offering more control."

Based on the Intellectual Creation Cycle:

- Background on the creator, inspiration and R&D process;
- IPRs acquired;
- Licensing / commercialization
- Business results including profit and reinvestment;
- Enforcement of IPRs (if any)
- Lessons learned.
