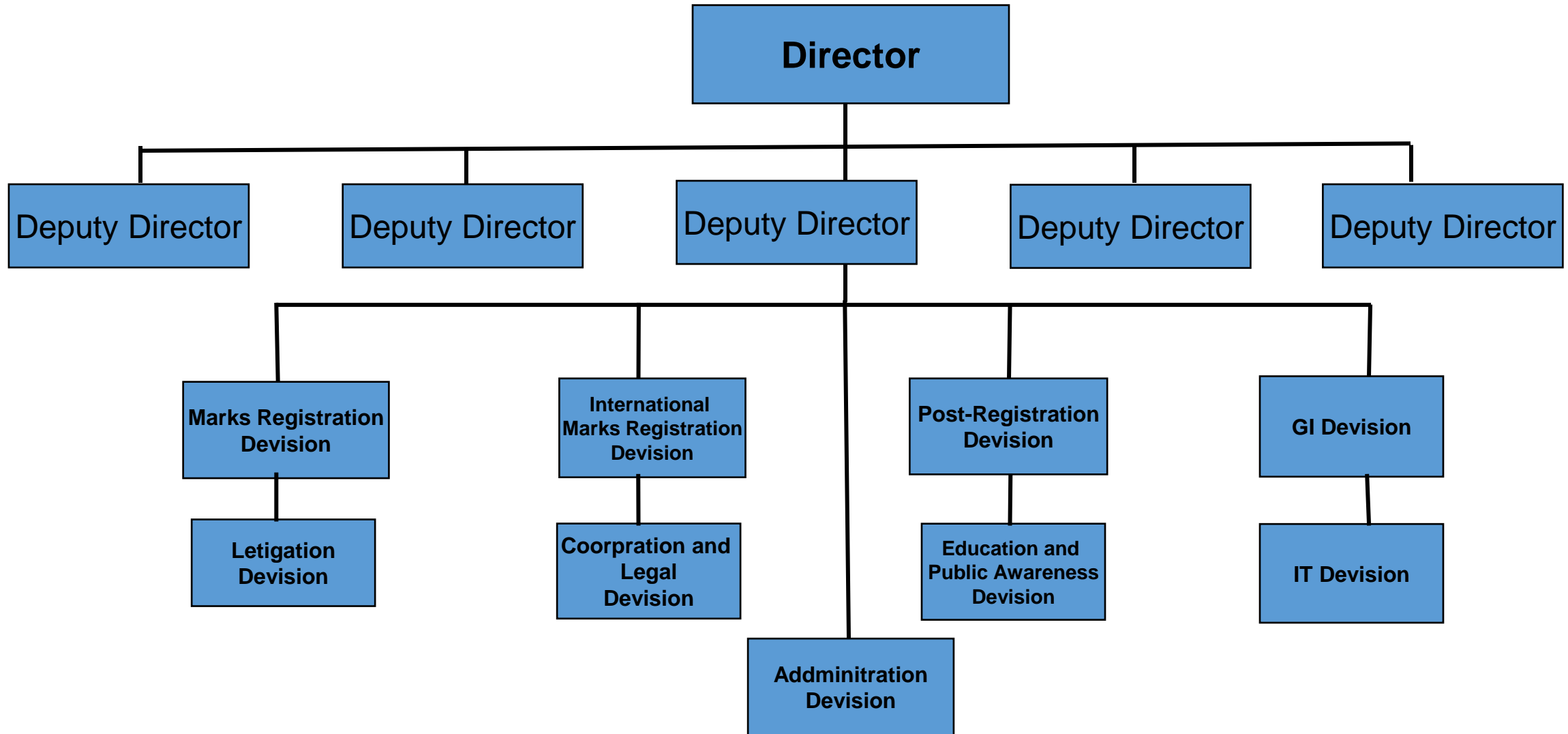
## Background

- March 05, 2015: Deposit of the instrument of accession to the Madrid Protocol
- June 05, 2015: Entry into force of the Madrid Protocol

# Declarations:

- 1) when refusal of protection may result from an opposition, such refusal may be notified to the IB after the expiration of the 18-month time limit (18 months +).
- 2) individual fee.
- 3) Affidavit Use or Non Use fee.

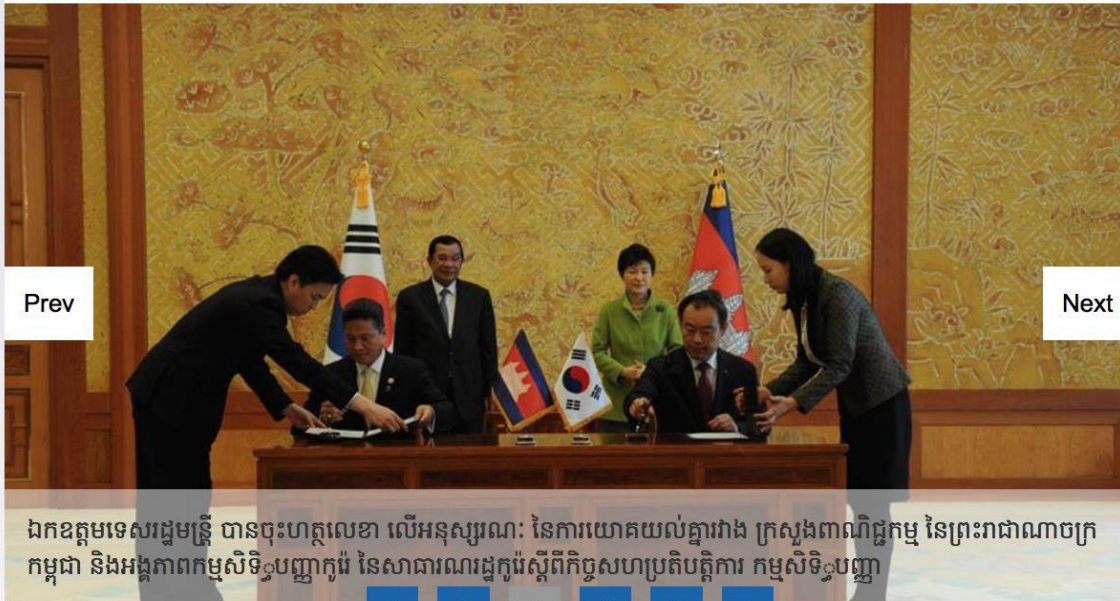
