The International Union for the Protection of New Varieties of Plants


Union internationale pour la protection des obtentions végétales

UPOV 条約

Adopted on December 2, 1961, by a Diplomatic Conference held in Paris

Came into force on August 10, 1968, having been ratified by the United Kingdom, the Netherlands and Germany. (1961 Act)

Revised on November 10, 1972
on October 23, 1978 (1978 Act)
and on March 19, 1991 (1991 Act)
```





The person who bred, or discovered and developed, a variety

任意的例外 OPTIONAL EXCEPTION TO THE BREEDER'S RIGHT (Farm-saved seed)

A Contracting Party may restrict the breeder's rights in order to permit farmers to use(農業者による利用):


- for propagating purposes on their own holdings
 the product of the harvest(自己の経営地において増殖目的で収穫物を使用)
- obtained on their own holdings from the protected variety (自己の経営地において栽培して得た収穫物を)
- within reasonable limits subject to safeguarding legitimate interests of the breeder(合理的な範囲内で、かつ、育 成者の正当な利益を保護することを条件として)





UPOV加盟国における出願件数の推移






地域ごとの出願件数の推移




